

As we look at the number of Americans who are embracing the concept of socialism as a viable system of government for the United States of America, one must ask, how did we get here? In William Federer's new book, *Socialism: The Real History, From Plato to the Present,* he poses and answers the question: Socialism: The dream of an ideal society? Is it a wonderful utopia or a totalitarian nightmare? References and quotes from his book make up much of the following information as we look at the birth and demise of societies.

In the 4<sup>th</sup> century BC, the Greek philosopher Plato¹ referred to the legendary island of Atlantis, which was supposedly a highly structured civilization, renowned for being advanced and powerful, and the ideal structured society. However, let's not forget that it was submerged into the sea.

Plato lived in Athens, which had a democracy (which was unstructured): *demos* means *people* and *cracy* means *to rule*. Democracy's chief characteristic is tolerance. Describing democracy, Plato declared that it was "a charming form of government, full of variety and disorder, and dispensing a sort of equality to equals and unequals alike; like a bazaar at which you can buy anything. There will be the greatest variety of human natures ... being an embroidered robe, which is spangled with every sort of flower. Freedom as they tell you in a democracy, is the glory of the state. The manner of life in such a state is that of democrats: **every man does what is right in his own eyes.**"

Subsequently, the tolerance of democracy allows citizens to tolerate people that are a little bit off. In due course, they tolerate people that are a lot off, and finally, they are tolerating crime, looting, lawlessness, with criminals wandering the streets. Freedom, unrestrained by private virtue, casts off moral restraints, results in licentiousness and sexual promiscuity. As Plato explained: "And so the young man passes into the freedom and libertinism of useless and unnecessary pleasures. In all of us there is a lawless wildbeast nature; in some persons they are controlled; while in others, they are stronger, and there is no conceivable folly or crime, when he has parted company with all shame and sense, a man may not be ready to commit."


Although a lawless wild-beast nature has pervaded our society without regard to age, Plato described the attitude of youth as "from his youth upwards to have been trained under a miserly parent, who encouraged the saving appetites in him and then he got into the company of a licentious sort of people, and taking to all their wanton ways rushed into the opposite extreme from an abhorrence of his father's meanness. Neither does he receive advice, if anyone says to him that some pleasures are evil desires, he shakes his head. He lives from day to day indulging the appetite of the hour. His life has neither law nor order. He is all liberty and equality." This attitude is prevalent in youth today who have taken on attitudes of selfish, thoughtless behavior as they burn cities to the ground in protests.

However, all age groups seem to be entering into rampant lawless behavior on the streets of America's cities. In *The Lessons of History,* historians Will and Ariel Durant quote Plato's Republic: "The teacher fears and flatters his

students, and the students despise their masters and tutors. The old do not like to be thought morose and authoritative, and therefore they imitate the young."2 It is a condition that continually grows like a snowball rolling down a hill that cannot be stopped. As Samuel Johnson wrote, "Temptation succeeds temptation. We, in time, lose the happiness of innocence with sensual gratifications ... immerse ourselves in luxury. We then look back upon our lives with horror, with sorrow, and with repentance; and wish, but too often vainly wish, that we had not forsaken the paths of virtue."3

### **ECONOMY**

The current state of affairs in some of our major cities has created wastelands where there used to be vibrant business and commerce. Protest and violence have a tremendous effect on our economy. Rob Garver wrote in the Voice of America News, "As business owners and residents yet again clean up the debris, there is growing concern that the economic damage to many of the communities where violence is taking place will persist long after the last window pane is replaced and the last burned out car is towed away. Businesses and neighborhoods where protests have turned violent will have to contend not just with the aftermath of the protests, but with multiple aggravating factors that will make recovery even more difficult." Plato warned: "Can liberty have any limit? Certainly not, by degrees the anarchy finds a way into private houses. The son is on a level with his father, he having no respect or reverence for either of his parents; and this is his freedom. They will have no one over them. Citizens then yield to selfishness and vote to spread the city's wealth around, draining the treasury."

We see this in the continuing demands for more money than the nation has, nor can possibly afford to spend, for relief from the effects of the coronavirus. These monies in the trillions of dollars were allocated on the state and individual level. And yet, the House of Representatives is demanding more and more money to be added going forward. Alarm bells should be going off.

When the city (or nation) runs out of money, Plato explained they vote to take money from the rich. "Their leaders deprive the rich of their estates and distribute them among the people; at the same time taking care to reserve the larger part for themselves. And the persons whose property is taken from them are compelled to defend themselves before the people as they best can." That is certainly a clear definition of the political and economic theory of social organization, which advocates that the means of production, distribution, and exchange should be owned or regulated by the community as a whole.

### Four Stages of Culture

After studying 86 different tribes and civilizations over 5,000 years, including Sumerians, Babylonians, Greeks, Romans, Teutons, and Anglo-Saxons, Oxford anthropologist, J. D. Unwin found that sexual promiscuity always preceded the decline of a civilization. Unwin concluded that cultures go through four stages:

- People go through a painful time of struggle, famine, poverty, or war.
- They then exhibit self-discipline and become productive, innovative,

- protective, patriotic, pioneering and expansionistic.
- Eventually, they become prosperous and enjoy abundance.
- Finally, they become lax, cast off discipline, abandon self-restraint, lose courage and become weak. They indulge in self-gratification, decadence, lawlessness, the pursuit of pleasure and sexual promiscuity.5

Even though many throughout history have warned or predicted a decline in our culture, America seems to have entered into the fourth stage of decline. Evidence of this deterioration in our society is the rampant lawlessness, the calls to defund the police, and the attitudes toward destruction as a way to effect change. But it is nothing new.

Examples of strong warnings include Solzhenitsyn comments to a graduating class at Harvard University: "Young people (seek) happiness; possession of material goods, money, and leisure, toward an almost unlimited freedom in the choice of pleasures. Voluntary self-restraint is almost unheard of; irresponsible freedom has turned out to have scarce defense against the abyss of human decadence."6 This was not always the case. Long before Solzhenitsyn spoke, on the anniversary of the Boston Massacre, John Hancock wrote: "Suffer not yourselves to be betrayed, by the soft arts of luxury and effeminacy, into the pit digged for your destruction." John Adams queried Thomas Jefferson, "Have you ever found in history one single example of a nation thoroughly corrupted that was afterwards restored to virtue? And without virtue, there can be no political liberty. Will you tell me how to prevent luxury from producing effeminacy, intoxication, extravagance, vice and folly? No effort in favor of virtue is lost."8 Encouraging America to reestablish its moral and spiritual principles, General Douglas MacArthur said, "History fails to record a single precedent in which nations subject to moral decay have not passed into political and economic decline. There has been either a spiritual awakening to overcome the moral lapse, or a progressive deterioration leading to ultimate national disaster."9

In stark contrast, vice presidential nominee, Kamala Harris, proclaimed recently at the NAACP's national convention that, "... 'nothing that we have achieved that has been about progress, in particular around civil rights, has come without a fight, and so I always am going to interpret these protests as an essential component of evolution in our country – as an essential component or mark of a real democracy. ...' Harris also praised the brilliance and impact of Black Lives Matter, which has received media praise but also come under fire for promoting left-wing stances like opposing the nuclear family. 'I actually believe that *Black Lives Matter* has been the most significant agent for change within the criminal justice system,' she said."10

Explaining how the chaos causes citizens to look for someone to come along and fix this mess, Plato maintained, "Democrats contemptuously rejected temperance. Citizens chafe impatiently at the least touch of authority, and at length, they cease to care even for the laws, written or unwritten. And this is the fair and glorious beginning out of which springs dictatorship (tyrannis). The excessive increase of anything causes a reaction in the opposite direction. And so dictatorship naturally arises out of democracy, and the most aggravated form of tyranny and slavery out of the most extreme form of liberty."11 Are we witnessing this chaos on the streets of America today?



### BATTLE FOR VIRTUE

Further examples of those who have taken a stand for virtue are Rep. Fisher Ames, who proposed the wording of the First Amendment, explaining that without virtue, "democracy could not last. When the tyranny of the majority leads to chaos, society will submit to rule by the sword." In 1792, British Statesman Edmund Burke said, "What is liberty without virtue? It is the greatest of all possible evils ... madness without restraint. Men are qualified for civil liberty in exact proportion to their disposition to put moral chains upon their own appetites. Society cannot exist, unless a controlling power upon will and appetite be placed somewhere; and the less of it there is within, the more there must be without."

Once citizens abandon virtue, lawlessness causes them to look for someone to restore order. A governor comes along who promises to fix the situation but demands emergency powers, and in the end, rules as a despot. In James Monroe's inaugural address, he said, "When the people become ignorant and corrupt, when they degenerate into a populace (mob), they are incapable of exercising the sovereignty. Usurpation is then an easy attainment, and a usurper soon found. The people themselves become the willing instruments of their own debasement and ruin." 12

### WITHOUT VIRTUE, WHERE IS LIBERTY?

President Harry S Truman stated, "Without a firm moral foundation, freedom degenerates quickly into selfishness and license. Unless men exercise their freedom, within moral restraints, a free society can degenerate into anarchy. Then there will be freedom only for the rapacious, and more unscrupulous than the rank and file of the people." <sup>13</sup>

In the confusion, a governor seizes power, as Plato wrote: "Last of all comes the tyrant. In the early days of his power, he is full of smiles, and he salutes everyone whom he meets, making promises in public and also in private, liberating debtors, and distributing land to the people and his followers, and wanting to be so kind and good to every one. This is the root from which a tyrant springs; when he first appears above ground, he is a protector. He begins to make a party against the rich (to make them) impoverished by payment of taxes, and thus compelled to devote themselves to their daily wants and therefore less likely to conspire against him."

Plato explained that the tyrant governor incites mobs to target his political opponents: "Having a mob entirely at his disposal, he is not restrained from shedding the blood of kinsmen; by the favorite method of false accusation he brings [his opponents] into court and murders them, and if any of them are suspected by him of having notions of resistance to his authority, he will have a good pretext for destroying them." Until finally: "Standing up in the chariot of state with the reins in his hand, no longer protector, but tyrant absolute."

He also described Athens' equivalent of Hollywood and fake news: "[The tyrant] will hire voices fair and loud and persuasive, and draw the cities over to tyrannies. Moreover, they are paid for this and receive honor. Poets are the eulogists of tyranny praising tyranny as godlike."





Washington warned in his Farewell Address, 1796: "Disorders and miseries gradually incline the minds of men to seek security and repose in the absolute power of an individual [who] turns this disposition to the purposes of his own elevation, on the ruins of public liberty."

President William Henry Harrison warned: "The tendencies of all such governments in their decline is the spirit of faction. In times of great excitement imposes itself upon the people as the genuine spirit of freedom, and, like the false christs whose coming was foretold by the Savior, seeks to, and were it possible would, impose upon the true and most faithful disciples of liberty."

### **CORONAVIRUS TYRANTS**

In the beginning of the lockdowns in cities because of the spread of COVID-19 looming on the horizon, some in authority have overreached their dominance in their cities. John Daniel Davidson remarked in an article in *The Federalist*, "Some mayors and governors seem to think their authority is limitless in the face of the pandemic. They need a remedial lesson in the Constitution. They think they have unlimited and arbitrary power over their fellow citizens, that they can order them to do or not do just about anything under the guise of protecting public health. We've now witnessed local and state governments issue decrees about what people can and cannot buy in stores, arrest parents playing with their children in public parks, yank people off public buses at random, remove basketball rims, … ticket churchgoers, and in one case try—and fail—to chase down a lone runner on an empty beach. *All of this, we're told, is for our own good*."<sup>14</sup>

As citizens, we are accountable for what responsibility we hold to those we love and to those with whom our lives touch. It is critical that we question the authoritative reach of elected officials. Bertrand Russell warns us that, "holders of power become increasingly tyrannical ... Power over human beings is shown in making them do what they would rather not do, the man who is actuated by love of power is more apt to inflict pain than to permit pleasure." Commenting on what is now referred to as *cancel culture*, President Harry S Truman warns that we must not "... forget the examples of such men as Washington, Jefferson, and Andrew Jackson [so that] we will [not] start down the road to dictatorship and ruin." 16

Neither can we forget the past or right the wrongs of it by destroying statues or memorials even if they represent questionable events or notability. In an article on *ForeignPolicy.com*, Justin Jampol observed, "If the statues survive, they will become memorials instead of monuments, just in the way that sites of the Holocaust were first destroyed out of anger and then fastidiously preserved as evidence of historical crimes and injustices. The barracks at the infamous concentration camp at Dachau were first removed and then later reconstructed, with furnishings from three different periods, presenting a three-phase narrative of the Holocaust while showing visitors the unspeakable conditions that prisoners faced."<sup>17</sup>

Jampol explains another instance of trying to erase history which happened after the Berlin Wall fell: "... graffiti-painted concrete segments of the Berlin Wall

were hastily removed, ground up by machines that rolled along the border while physically chewing it up, and, poetically, turned into asphalt to repave the crumbling streets of the former East Berlin. The people of Berlin, who had lived in the shadow of the wall for decades, celebrated the cement edifice's demise. They were so thorough, so confident in the righteousness of their cause, that nearly all of the original pieces were either removed from their original positions or destroyed. [Now the] German media is full of talk about historical amnesia. Young people do not remember the wall or what their parents had to endure. A key lesson has been lost, the older generation contends. Their solution? Segments of the Berlin Wall are being reproduced and replaced in strategic positions around the city, including at perhaps the most infamous, most public site of all: the former Checkpoint Charlie. But this time, there is an audio guide, ample signage, and the opportunity to talk about the wall as an oppressive structure that separated friends, colleagues, and family." 18

### AMERICAN CONSTITUTION

Writing in his memoirs, President Truman encouraged us to continue to uphold our constitution, which was written by men who "were all well informed on the history of government from Babylon to Britain ... The most important thought expressed in our Constitution is that the power of government shall always remain limited, through the separation of powers." Patrick Henry continued, "When the American spirit was in its youth, liberty was then the primary object. But now, assisted by the ropes and chains of consolidation there will be no checks, no real balances." John Adams wrote, "The only foundation of a free Constitution is pure virtue, and if this cannot be inspired into our people in a greater measure, than they have it now, they may change their rulers and the forms of government, but they will not obtain a lasting liberty."

Democracy was doomed to fail because people really do not have virtue, envisaged Plato. If you give them the choice of giving up their virtue or giving up their life, they will always give up their virtue to save their life. He asserted that "if a truly just man lived, let him die as he has lived. ... the just man will be scourged, racked, bound, and will at last be crucified."

The ancient Hebrew republic lasted longer than the democracy of Athens, because it had a big *magnet in the sky*, so to speak, the awareness that each person was accountable to God in the next life. Athens did not have that. By Plato's time, the Greek gods were fickle deities that no one really believed in. Plato concluded the best one can hope for is a nice tyrant – a philosopher king. This tyrant would set up a structured society, consisting of a ruling class and the ruled class. **This is the origins of socialism**.

The tyrant-king is the head of gold, and his political party are the arms and chest of silver. Together they are the ruling class. They are a deep state, above the law. Everyone else is in the ruled class – the abdomen of bronze and iron, the worker class. These own no property, have no families, government decides who gets to have children, government takes children away from parents and *socializes* them in government schools, teaching them *noble lies* so they will obey the ruling class.

Initiated in the late 1970s and early '80s by the central government of China, the one-child policy seems to have reached its unthinkable conclusion. Originally, the purpose was to limit the great majority of family units in the country in order to reduce the growth rate of China's enormous population. It is evident now that the birth rate is so low that "by 2050, a third of the country's population will be made up of people over the age of 60, putting severe strain on state services and the [one-child policy] children who bear the brunt of caring for elderly relatives." China's one-child policy ended on January 1, 2016, but now the challenge is encourage families to have more than one child.

It seem like China's policies were written out of Plato's playbook which asserts that "... the true philosopher kings will set in order their own city; take possession of the children, who will be unaffected by the habits of their parents; these they will train in their own habits and laws."

### LOOKING FOR UTOPIA

Utopia means *nowhere*. It supposedly was a fictitious island discovered somewhere off coast of South America. After Columbus discovered the New World, there was a fascination among Europeans scholars of setting up structured societies. Inspired by Plato, Sir Thomas More wrote "Island of Utopia," which was a story whose fictional traveler was Hythlodeus, whose name means *peddler of nonsense*. Utopia consisted of an upper class rulers and lower-class commoners.

The society offered: free healthcare; free identical clothing; communistic welfare lifestyle; shared identical public housing; no locks on doors; common meals in monastic communal dining halls; no private property; all goods stored in communal warehouse; no taverns, no alehouses, no coffeehouses; no places for private gatherings; no privacy; everyone tracked everywhere they went; government decides everyone's careers; no families ("takes a village to raise a child"); marriage & childbearing regulated by government (i.e. China's one-child policy/Planned Parenthood's Margaret Sanger: "No woman shall have the legal right to bear a child without a permit").

Sir Francis Bacon was influenced by Plato's "Island of Atlantis" and Sir Thomas More's "Island of Utopia," when he wrote "The New Atlantis," which was a fictitious island in the South Pacific off the coast of Peru. It was highly structured with a ruling class and a ruled class. The government controlled everyone's life, even dictating careers. It was more scientific, as the Scientific Revolution had taken place by this time.

Spring boarding from Bacon's "New Atlantis," Jonathan Swift wrote a parody titled "Gulliver's Travels." Gulliver was shipwrecked on the Island of Lilliput and observed the ridiculousness of their highly structured society of a governing class and a governed class. It is of note that neither Plato's, More's, nor Bacon's imagined socialist societies have ever been realized, nevertheless, naive youth are not dissuaded from continually trying.

### FOUNDATIONAL GOVERNMENT OF THE COLONIES

Of considerable interest is the fact that Plato, More, and Bacon influenced the Pilgrim colony in Massachusetts. Originally, the Pilgrims were a "company" colony with bylaws written by investors who made everything owned in common – "a communistic plan." Pilgrims tried it, but almost starved to death!

The bylaws of the Pilgrims' company colony stated, "all profits & benefits that are got by trade, traffic, trucking, working, fishing, or any other means... remain still in ye common stock. All are to have their meat, drink, apparel, and all provision out of ye common stock & goods. That at ye end of ye seven years, ye capital & profits, viz. the houses, lands, goods and chattels, be equally divided betwixt ye adventurers, and planters."

According to Governor William Bradford, "The failure of that experiment of communal service, which was tried for several years by good and honest men proves the emptiness of the theory of Plato and other ancients applauded by some of later times that the taking away of private property, and the possession of it in community would make a state happy and flourishing; as if they were wiser than God. For in this instance, community of property was found to breed much confusion and discontent; and retard much employment, which would have been to the general benefit and comfort. ... It did greatly diminish the mutual respect that is so important should be preserved amongst them. Let none argue that this is due to human failing, rather than to this communistic plan of life in itself. ... Seeing that all men have this failing in them, that God in His wisdom saw that another plan of life was fitter for them. So they began to consider how to raise more corn, and obtain a better crop than they had done, so that they might not continue to endure the misery of want. At length after much debate, the Governor, with the advice of the chief among them, allowed each man to plant corn for his own household. So every family was assigned a parcel of land, according to the proportion of their number. This was very successful."

The Pilgrims dispensed with the bylaws and set up a covenant form of government, based on ancient Israel during the 400 year period when they first came out of Egypt, before they got their first king, Saul. It was referred to as the *Hebrew Republic* and was taught at Harvard and Yale. In his address to the New Hampshire Ratifying Convention, Samuel Langdon, explained "Instead of the twelve tribes of Israel, we may substitute the thirteen States of the American union, and see this application plainly."<sup>21</sup>

The Pilgrims' covenant form of government introduced biblical concepts, such as:

- Government should be by the consent of the governed
- Government's purpose is to secure to individuals their God-given rights
- All men and women were equal, made in the image of God
- There should be no respect of persons in judgment

A century after the Pilgrims, during the Age of Enlightenment, the word covenant transitioned into *social contract*. Instead of people being accountable to God to care for each other, it simply became people *in agreement* with or without God. If God existed, He was considered distant, removed, and impersonal – a concept birthed out of the scientific revolution. A century after that, the French Revolution transitioned social contract with *a distant god* into social contract with *absolutely no god*. The last phase has been Marxism, socialism, and communism wherein we have the social contract made into the *state god*.

After World War I, Henry Cabot Lodge warned, "Look at the United States today, we have had shortcomings. But nonetheless, is there any country today on the face of the earth, which can compare with this in ordered liberty, in peace, and in the largest freedom? If the United States fails, the best hopes of mankind fail with it. The United States is *the world's best hope.* Beware how you trifle with your marvelous inheritance, this great land of ordered liberty. For if we stumble and fall, freedom and civilization everywhere will go down in ruin."<sup>22</sup>

### Missouri Ballot Issues



## Amendment 1: State Executive Term Limits

he legislation backing Amendment 1 was passed in 2019, but was slated by the governor to be placed on the November 2020 ballot. The Missouri Constitution currently places a limit of a maximum two terms on the offices of governor and treasurer. The other three statewide offices do not currently have term limits. All representatives and senators have term limits of four maximum terms and two maximum terms respectively. This amendment would bring all statewide offices into alignment with the limitations placed on both chambers of the legislature.

### Ballot Language:

Do you want to amend the Missouri Constitution to extend the two term restriction that currently applies to the Governor and Treasurer to the Lt. Governor, Secretary of State, Auditor and the Attorney General?

A "yes" vote supports this constitutional amendment to limit the lieutenant governor, secretary of state, state auditor, and attorney general, along with the governor and state treasurer, to two terms of office.

A "no" vote opposes this constitutional amendment, thereby keeping the twoterm limit on the governor and state treasurer but not other state executive offices

### Full Constitutional Language:

No person shall be elected governor, lieutenant governor, secretary of state, state auditor, state treasurer, or attorney general more than twice, and no person who has held the office of governor, lieutenant governor, secretary of state, state auditor, state treasurer, or attorney general, or acted as governor, lieutenant governor, secretary of state, state auditor, state treasurer, or attorney general, for more than two years of a term to which some other person was elected to such office shall be elected to that same office more than once. This subsection shall supersede the provisions of Article IV, 17 Section that relate to term limitations, provided that service in the offices of governor or state treasurer resulting from an election or appointment, or in the case of the governor succession to office, prior to December 3, 2020, shall count towards the limitations provided in this subsection.

**PROS:** Political officeholders should view their terms as a temporary civic duty, not a career. The power of incumbency (relationships with donors, lobbyists, influencers, voters) is too great to overcome through the normal election process. Term limits allow those with new ideas or a fresh take on an old problem to have a shot at the office. Knowing that they only have two terms in which to accomplish their agenda means that, at least for the second term, they are not focused on fundraising and campaigning.

The timing of this legislation after the passage of *Clean Missouri* could also be a factor in its passage.

**CONS:** Typical arguments against term limits contend that such limits remove the power from voters in favor of an arbitrary law. A popular or effective officeholder would not be re-electable if their term had run out.

Another point made by those who support term limits is that they remove the outsized power that longer tenured office holders have. Their longevity and influence allows them to bring more "pork" back to the district they serve. Term limits would remove this incentive for their constituents to send them back. While that may be true in D.C., or even our state legislature, that is not the case for statewide office holders. They have no peer group to dominate or subset of the state to serve.

## Amendment 3: Redistricting Process and Criteria, Lobbying, and Campaign Finance

n 2018, significant money from outside Missouri targeted our state to try to change its political make up with Amendment 1, known as *Clean Missouri*. The National Democrat Redistricting Committee targeted twelve states to change the district boundary drawing process in order to tip the polls in favor of Democrats, and *Clean Missouri* was the vehicle for doing that. The ballot measure included other fairly insignificant ethics changes which were the primary focus of campaigns in favor of the amendment.

### Ballot Language:

"Shall the Missouri Constitution be amended to: Ban gifts from paid lobbyists to legislators and their employees; Reduce legislative campaign contribution limits; Change the redistricting process voters approved in 2018 by: (i) transferring responsibility for drawing state legislative districts from the Nonpartisan State Demographer to Governor-appointed bipartisan commissions; (ii) modifying and reordering the redistricting criteria.

State governmental entities expect no cost or savings. Individual local governmental entities expect significant decreased revenues of a total unknown amount."

"A 'yes' vote will amend the Missouri Constitution to reduce the limits on campaign contributions that candidates for state senator can accept from individuals or entities by \$100 per election. There is no change for candidates for state representative.

The amendment prohibits state legislators and their employees from accepting a gift of any value (which is currently \$5) from paid lobbyists or the lobbyists' clients.


The amendment modifies the criteria for redrawing legislative districts and changes the process for redrawing state legislative district boundaries during redistricting by giving redistricting responsibility to a bipartisan commission, renames them, and increases membership to 20 by adding four commissioners appointed by the Governor from nominations by the two major political party's state committees.

A 'no' vote will not amend the Missouri Constitution regarding campaign contributions, lobbyist gifts, and the process and criteria for redistricting.

The new system put responsibility for redrawing district lines in the hands of one person, a demographer, appointed by the State Auditor's Office (the only statewide office currently held by a Democrat) and not the Secretary of State's office, which is in charge of all elections in the state. The demographer's mission was to "balance" the districts between the major parties, leaving all Libertarian, Constitutional and Green party members completely out of the picture. Since we do not register for parties in this state, various assumptions would have to be made by the demographer to determine which party the voters of any district were most closely affiliated with. This would, without question, introduce the bias of the demographer, or those advising the demographer, into the redrawing process.

Amendment 1 (2018) passed even though many voters did not understand what they had voted for since the ballot language only said it would "Change process and criteria for redrawing state legislative districts during reapportionment." The legislature wanted to remove the bias in the process and give the public the opportunity to vote for a redistricting process that would be clearly explained on the ballot. Their ballot language stated that redistricting would require the creation of "citizen-led independent bipartisan commissions to draw state legislative districts based on one person, one vote, minority voter protection, compactness, competitiveness, fairness and other criteria."

# "GOD SAVE THE UNITED STATES AND THIS HONORABLE COURT!"

estern Civilization generally, and America specifically, owes a tremendous debt to the Holy Bible for giving, among other things, form and substance to government, language, culture, and law. The Bible says, "Let every person be in subjection to the governing authorities. For there is no authority except from God, and those which exist are established by God." In 1215, the Magna Carta was signed limiting the power of the king for the first time. Less than fifty years later, renowned legal scholar Henry de Bracton noted that kings are not under man, but under God and under the law.<sup>2</sup> A shift had occurred in which law itself, not the authority of a king or individual, gives power and authority. This certainly included judges, commissioners, and other administrative officials who adjudicated matters between parties. Likewise in the 18th century, the Founding Fathers were aware of both biblical language and British history when they convened in Philadelphia and wrote both the Declaration of Independence, and later the United States Constitution. Article VI of the latter says plainly, "This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, and anything in the Constitution or Law of any State to the Contrary notwithstanding." (Italics added.) The judges that are appointed, elected, or retained in office are not the supreme law or the supreme lawgivers. That line must not be crossed. We have come too far to relinquish our freedoms to those in black robes.

od has placed leaders in authority. Whether these authorities are presidents, legislators, or judges, we should be respectful, because God is ultimately sovereign over all. Persons in these positions make a mistake thinking that they themselves are the objects of respect, rather than the position which they hold. A black robe, a raised dais, and a gavel are symbols of authority to be respected, but not feared. Judges hold a special place in our system, because they use discernment and wisdom to rule on issues of law. Nevertheless, the judges who are appointed by the executive, often for life, have tremendous authority to rule on cases that impact all of us every day. Who are these people? Who appointed them to literally sit in judgment? What recourse is there for removing those who abuse their discretion and authority?

The most esteemed and perhaps best-known judges in the nation are those we refer uniquely to as "Justices" and sit on the Supreme Court of the United States with a lifetime appointment from the president. Much less known are the judges of our own state here in Missouri. It is likely most people would be hard pressed to name even one of the judges on the Missouri Supreme Court. Yet these men and women, appointed by the governor of the state, make decisions, which affect all of us every day.

n Missouri alone, there are over 45 circuit courts with over 400 judges who preside over courtrooms throughout the state; including the Supreme Court (seven judges), the District Courts of Appeal that are divided into three geographic districts (Eastern, Southern and Western) (32 judges); and finally the circuit courts that sit in every county of the state. This does not take into consideration all of the various municipal judges, commissioners, and administrative law judges who are either elected or appointed to their constitutional positions. The men and women who make up the judiciary in the state are all fellow Missourians who are licensed by the State of Missouri to practice law and are required by oath to uphold the Constitution of the United States and the Constitution of the State of Missouri. Why? Because the Constitution, not the judge, is the supreme law of the land

As informed and concerned citizens of our state, we need to be aware of who is being placed in these important positions and hold them accountable to faithfully and honestly execute their roles as judgment makers without regard to personal whims/will from the law. Just like you and me, they are bound by state and national laws without regard to race, creed, status, or nationality.

he method of selecting judges in Missouri is known as the Nonpartisan Court Plan, or the "Missouri Plan," which has been used in Missouri since 1940 and has become the model for dozens of other state judicial selection plans as a means to remove partisanship from the judiciary by using committees of lawyers and non-lawyers to select a slate of candidates from which the governor selects for appointment. This system (based on merit selection) uses the assisted appointment method by which the governor appoints state judges from a short list submitted by a review board. This process applies to the seven judges of the Missouri Supreme Court and the thirty-two judges of the Missouri Court of Appeals. Most circuit court judges are not chosen under the Missouri Plan, but are elected to office on a partisan basis. s citizens, we have a vested interest in all stages of judicial selection in order to maintain confidence in not just the process, but the outcome as well. Nonpartisan does not always translate into impartial and in the end, the decision is left to one person to select a candidate to become a judge. Transparency of process is always one key to ensuring integrity. That is the purpose of holding retention votes after each term. The Constitution does not give judges the option of going their own way or ruling subjectively from the bench as if free from any restraint or higher authority. Paragraph two of Article VI uses "shall" no less than four times in a single sentence. If the rule of law means anything, it means that no king, president,

judge, or other ruler is above the supreme law of the land: the Constitution. Thomas Jefferson said, "Whensoever the General Government assumes undelegated powers, its acts are unauthoritative, void, and of no force." Many are concerned that we are moving away from these principles, or worse, that we have long since moved on from them. In either case, we are morally obligated to either stop violating this principle or return to the standard so long observed and cherished in western civilization.

n November 3, 2020, Missourians will go to the polls to elect or retain a slate of judges in accordance with the law. Our purpose in this *FRONT LINE*, as always, is to provide basic facts regarding each of the judges appearing on the ballot. Where possible, if the judge has appeared in a news story that is significant to our readers, we include that information in order to give additional insight into the beliefs and actions of that judge. No recommendations for retention or removal are made, because that is the decision of the reader as an informed free American. We hope to simply provide relevant information for you to make an informed decision.

hen researching the judges, a variety of sources are accessed to pull information together for *Court Watch*. Sources include, but are not limited to, the Missouri Secretary of State website, "Official Manual" of the State of Missouri, a.k.a. the "Blue Book," showmecourts.org, ballotpedia. org, yourmissourijudges.org, and others. This information is meant to be a starting point for your own research depending on what part of the state you live. Knowing who your judges are is important, because today's associate circuit court judge could someday be on the Missouri Supreme Court. Elections always have consequences.

### MISSOURI SUPREME COURT

The highest court in Missouri has exclusive appellate jurisdiction in all cases involving: the validity of a treaty or statute of the United States or of a statute or provision of the Missouri Constitution; the construction of the state's revenue laws; the title to any state office; and in all cases where the punishment imposed is death.

In addition to its decision-making powers, the court supervises all lower courts in the state. The Supreme Court also licenses all lawyers practicing in Missouri and disciplines those found guilty of violation of the legal Rules of Professional Conduct. Supreme Court judges must be at least 30 years of age, U.S. citizens for 15 years, and qualified Missouri voters for nine years. Supreme Court judges are retained for 12-year terms.

### Court Watch cont'd

### **COURT OF APPEALS**

The Eastern District of the Court of Appeals sits in St. Louis and consists of fourteen judges. Eleven judges preside over the Western District in Kansas City, and seven judges sit on the Southern District bench meeting either in Springfield or Poplar Bluff. The Court of Appeals may issue and determine original remedial writs and has general appellate jurisdiction in all cases not within the exclusive jurisdiction of the Supreme Court. Cases may be transferred from the Court of Appeals to the Supreme Court when it is determined that a case involves an important issue that should be decided by the state's highest court. Judges must be at least 30 years of age; residents of their district; U.S. citizens for at least 15 years; and Missouri voters for nine years before their selection. Appellate judges serve 12-year terms.

### **CIRCUITJUDGES**

Circuit judges are selected either through popular vote or by appointment under the Nonpartisan Court Plan. These courts have original jurisdiction over civil and criminal causes of action. All trials start at this level. Circuit court judges must be at least 30 years old, residents of their circuit, and U.S. citizens for 10 years and Missouri voters for three years. Circuit judges serve six-year terms. The Constitution requires at least one circuit judge in each of Missouri's 45 judicial circuits. Circuit 6 is Platte County; Circuit 7 is Clay County; Circuit 16 is Jackson County; Circuit 21 is St. Louis County; and Circuit 22 is St. Louis City.

### **JUDGE EVALUATIONS**

The Missouri Bar has been evaluating judges appointed under the Non-Partisan Court Plan and providing that information to voters since 1948. The Missouri Bar currently funds the review process, which was created in 2008 and revised in 2016 by order of the Supreme Court of Missouri. The Missouri judicial performance review process was developed after a committee studied model rules and best practices from the American Bar Association and more than 20 judicial performance evaluation systems in the nation. The current judicial performance review process in Missouri was adopted June 15, 2016, when the Supreme Court of Missouri issued an order making revisions to Rule 10 which expand the voices of non-lawyers in the review process, leaves judging the judges to the voters, and fosters consistency in the process with the implementation of one statewide review committee.

The Missouri Judicial Performance Review Committee reviewed the performance of 52 judges, which included one Supreme Court of Missouri judge, four Court of Appeals judges, 26 circuit court judges and 22 associate circuit court judges in circuits where the judges are appointed under the Missouri Non-Partisan Court Plan. The committee found all 52 judges substantially meet overall judicial performance standards, and will up for retention in the November 3, 2020, general election.

### **U. S. SUPREME COURT**

Historically, twenty-nine Supreme Court vacancies have occurred in an election year, and every time, the sitting president announced a nominee. President Trump announced his nominee from the 7th U.S. Circuit Court of Appeals in Chicago -- Judge Amy Coney Barrett.

According to a recent article in *NPR*, Justice Barrett wrote in a 2013 law review article, "I tend to agree with those who say that a justice's duty is to the Constitution and that it is thus more legitimate for her to enforce her best understanding of the Constitution rather than a precedent she thinks clearly in conflict with it."

Last year [2016], she announced that Missouri judges would receive implicit bias training, saying that it is 'critical for those of us who sit in judgment of others to be aware of any bias, implicit or otherwise, that might unknowingly affect our decisions'."<sup>3</sup>

In her final State of Judiciary Address [January 24, 2017], Judge **Breckenridge** "touted modernized court computer system, but urged the Legislature to review which court documents should be made public on the courts' online system. 'It is safe to say statutes making certain case documents public meant available at the clerk's office, and in paper form, not available instantly to anyone anywhere in the world'."<sup>4</sup>

It is important to remember the role our Founding Fathers played in establishing the United States Constitution. Whether it's the how the candidates view the role of judges in making law, the raising of taxes, or national defense, the differences will make a significant impact on the nation depending on who is ultimately elected.

It is tragic that some Americans stand for a particular party or candidate, because their favorite song artist or their favorite actor/actress has endorsed them without regarding principles and our constitution. Disturbingly, the opposition against America and the blatant contempt against her leaders has become pervasive in our everyday lives.

There remains, however, a group of citizens who see our country as the best ▲ place on earth to live and are committed to educate, encourage and get involved in the political process. It is you, dear readers, that will stand up for principle and our constitution, and use God-given discernment by exercising your voting privilege for the good of our nation.

Information is obtained from various reliable sources and presented through the lens of the nation's highest law: the United States Constitution. News sources are footnoted; otherwise sources used were ProCon.org, Ballotpedia.com, VoteSmart.org, or the candidate's websites. (See the "Ratings and Endorsements" Page 29 for an explanation of the positions/viewpoints/policies of the groups who have made ratings/endorsements of the candidates. By no means is this list exhaustive.) None of the information provided is intended, nor should it be construed, to be an endorsement of any party or candidate. We have not included candidates in this review who have not been certified for all 50 state ballots.1



## PRESIDENT/VICE-PRESIDENT CANDIDATES of the United States of America

### **DONALD J. TRUMP** (Republican, Incumbent)

President Trump has kept his promise to uphold the RNC Platform by defending religious freedom, instituting policies to uphold the sanctity of life, taking decisive action to strengthen our military, securing our borders, eliminating burdensome federal regulations, simplifying the tax code, renegotiating unfair trade agreements, and moving the U.S. Embassy to Jerusalem.<sup>2</sup>

"Just weeks after helping to broker peace between Israel and the United Arab Emirates (UAE), President Trump [was] nominated for the 2021 Nobel Peace Prize. 'For his merit, I think he has done more trying to create peace between nations than most other Peace Prize nominees,' Tybring-Gjedde

... [said]'."<sup>3</sup> (Christian Tybring-Gjedde is a member of the Norwegian Parliament and chairman of the Norwegian delegation to the NATO Parliamentary Assembly.)

**ABORTION:** On January 19, 2018, ... President Donald Trump said that his administration "will always defend the right to life. ... We are protecting the sanctity of life and the family as the foundation of our society." "As most people know ... I am strongly pro-life, with the three exceptions: rape, incest and protecting the life of the mother – the same position taken by Ronald Reagan." Donald Trump, twitter.com, May 18, 2019.

Trump's major actions on abortion during his first two years in office were: signing into law a resolution that allowed states to withhold federal funding for health care providers that perform abortions; reinstating the Mexico City Policy, which prohibited foreign aid and federal funding for international NGOs that performed abortions or offered related services; and proposed modifying the Title X family planning program making family planning clinics that refer patients or resources with abortion providers ineligible to receive funding. Additionally, healthcare providers would not be required to provide abortion counseling if it violated their moral or religious beliefs.

**ECONOMY:** The Tax Cuts and Jobs Act; the first major tax reform signed in 30 years; provided tax relief for 82% of middle-class families; doubled the Child Tax Credit to \$1,000 per child; nearly doubled the standard deduction, cut taxes for small business by 20%, providing \$415 billion in tax relief for small business owners, alleviated the tax burden on over 500 businesses, resulting in \$482 billion invested in new American projects, repealed Obamacare's burdensome individual mandate; lowered the corporate tax rate from one of the highest in the industrialized world from 35% to 21%. Launched the Women's Global Development and Prosperity (W-GDP) Initiative, which advanced women's full and free participation in the global economy and allocated \$50 million for the fund.

According to the U.S. Bureau of Labor Statistics, the U.S. labor market remained strong in 2019, as the unemployment rate fell to 3.5 percent, the lowest rate since 1969. Levels of long-term joblessness and involuntary part-time employment continued to trend down.

**EDUCATION:** The President's FY2018 Budget Request included \$1 billion in funding grants for public school choice and \$250 million to promote private school choice. In his FY2019, budget President Trump proposed a \$5 billion federal tax credit for donations that fund scholarships to private and vocational schools, apprenticeship programs and other educational opportunities. His administration successfully implemented the Every Student Succeeds Act (ESSA) to empower states to better educate their students. To date, 35 states and the District of Columbia have had their ESSA plans approved. They also implemented year-round distribution of Pell grants. Low-income students now have access to funds over summer and winter breaks, so they can earn their degrees faster with fewer loans. The Trump Administration reformed the student loan servicing process to improve customer experience and lower costs. They have modernized the way FSA offers and services student loans. The Department of Education provided \$359.8 million in federal assistance to 20 states and the U.S. Virgin Islands to assist with the cost of educating students displaced by natural disasters.

**HEALTHCARE:** "... Donald Trump has proposed to repeal the Affordable Care Act (ACA) and replace it with a proposal titled 'Healthcare Reform to Make America Great Again'. ... recommended reforms include full deduction of premiums for individual health plans on federal tax returns, providing block grants to finance state Medicaid programs, and allowing insurers to sell insurance across state lines. His goal: To assess how each of these reforms, when implemented individually, would affect insurance coverage, consumer out-of-pocket spending on health care, and the federal deficit. Since the Affordable Care Act was enacted in 2010, critics have advocated that the law be repealed and replaced with an alternative set of reforms."

**COVID-19:** The World Health Organization declared a public health emergency of international concern over the coronavirus outbreak on January 30, 2020. The following day,

President Trump introduced a temporary ban on the admission of people who were in China 14 days prior to their travel to the United States. "... Dr. Anthony S. Fauci, the director of the National Institute of Allergy and Infectious Diseases, praised 'the original decision that was made by the president' to impose travel restrictions to and from China. 'We prevented travel from China to the United States', said Fauci, who has worked for multiple administrations. 'If we had not done that, we would have had many, many more cases right here that we would have to be dealing with'."<sup>5</sup>

The Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed by Congress with overwhelming, bipartisan support and signed into law by President Trump on March 27th, 2020. This over \$2 trillion economic relief package delivers on the Trump Administration's commitment to protecting the American people from the public health and economic impacts of COVID-19. The CARES Act provides *fast and direct* economic assistance for American workers, families, and small businesses, and preserve jobs for our American industries.<sup>6</sup>

**IMMIGRATION:** Recommended anti-fraud and abuse measures, protecting the integrity of the H-2B visa program. Announced that last month border officials handled fewer than 40,000 illegal crossings, the lowest rate in two years. With over 100 miles of wall built, he has fulfilled his promise to secure the border. Provided funding to support the National Human Trafficking Hotline.

**LAW AND ORDER:** \$98 million in grant funding through the Office of Community Oriented Policing Services COPS Hiring Program to allow 802 additional full-time law enforcement officers. Signed Executive Order 13809 to restore state and local law enforcement's access to surplus equipment from the Defense Department. Created the new National Public Safety Partnership to help cities reduce violent crimes. Expanded Project Safe Neighborhoods to encourage U.S. Attorneys to work with communities to develop customized crime reduction strategies, resulting in a 23 percent increase in arrests for unlawful possession of a firearm.

Stands firm that Black Lives Matter is a Marxist organization. [See description of Black Lives Matter parent organization under "Ratings/Endorsements," page 29, this issue.] "What we can never have is mob rule, and the Republican Party condemns the violence in Democrat-run cities." (RNC Acceptance Speech, 2020)

**NATIONAL DEFENSE:** "… helped broker a deal between the United Arab Emirates and Israel and then another with Israel and Bahrain, uniting the countries in peace and diplomatic relations. The agreements, collectively called the Abraham Accords, are the first of its kind since 1994 and commit the nations to an exchange of embassies and ambassadors and to work with each other in educational, healthcare, trade, and security initiatives, among other fields.<sup>7</sup>

Put maximum pressure on North Korea to denuclearize. In June 2019, President Trump became the first sitting U.S. President to enter North Korea, holding a historic meeting with Kim Jong Un at the DMZ. The president confronted Iran's aggression by withdrawing from Obama's flawed Iranian nuclear deal and ordered missile strikes against a Syrian airbase after the Assad regime used it to launch chemical weapons attacks against civilians. Placed sanctions on North Korea for its use of chemical weapons in the assassination of Kim Jong UN's stepbrother. He imposed numerous sanctions on the Maduro dictatorship in Venezuela. The Trump Administration has led the world in support of Juan Guaido, the Democratic elected leader of the Venezuelan General Assembly. Has approved more than \$250 million in regional aid to address the humanitarian crisis in Venezuela.

Has directly confronted Russia for its threatening behavior, bolstering allies in the region. Has imposed diplomatic penalties on Russia including the expulsion of more than 50 Russian intelligence officials and the closing of two Russian consulates. Placed sanctions on Russia for its use of chemical weapons involving an attempted assassination of a former KGB spy in Britain. Led support for Ukraine's Armed Forces to help Ukraine improve its defense. Has pressured NATO allies to meet their spending commitments and by the year 2019, NATO allies have increased their spending by nearly \$100 billion since 2016.

Under Trump, the National Defense Authorization Act established the United States Space Force (a new branch of the military), ensuring American dominance in space, and modernizing the U.S. military to meet the security needs of the 21st century. It granted \$738 billion for defense spending including the first ever paid family leave and much needed 3.1% pay raise for our troops. He revived the National Space Council to develop and implement a new national space policy and strategy.

### JOSEPH R. BIDEN (Democrat)

Born in Scranton, PA. Raised in Claymont, DE. Received BA, University of Delaware and JD, Syracuse University. Married with two sons (one son deceased) and one daughter (deceased); widowed; remarried with one daughter. U.S. Senate (1972-2008); ran unsuccessfully for president in 1988 and 2008; elected 47th Vice President of the United States (2008), serving two terms with Barak Obama.

**ABORTION:** "As president, Biden will be a champion for improving access to health care and the health of all by: Expanding access to contraception and protect the constitutional right to an abortion ... Reverse the Trump

Administration and states' all-out assault on women's right to choose. As president, will work to codify Roe v. Wade, and his Justice Department will do everything in its power to stop the rash of state laws that so blatantly violate the constitutional right to an abortion, such as so-called TRAP laws [Targeted Restrictions on Abortion Providers], parental notification requirements, mandatory waiting periods, and ultrasound requirements." Source: "Healthcare," www.joebiden.com.

"Despite supporting the Hyde Amendment for his entire public career, Biden reversed his position last summer and now supports federal funding for abortion. Biden has promised to ... make support for abortion a litmus test for nominees to the Supreme Court. He has also vowed to make passage of the Equality Act a top legislative priority during his first 100 days as president.<sup>8</sup>

**ECONOMY:** Promises to "... end this epidemic [pandemic] and get our economy back on track through bold action; launch a task force reporting directly to me to make sure every dollar going out the door gets to the people who need it — fast; bring the leaders of Congress together to build the next deal."

**EDUCATION:** "Outlining a plan that 1) provides educators the support and respect they need and deserve, and 2) invests in all children from birth, so that regardless of their zip code, parents' income, race, or disability, they are prepared to succeed in tomorrow's economy." Competitive wage, help teachers pay off student loans, double counselors in schools, defeat NRA to make schools safer, eliminate funding gap, improve teacher diversity, and pursue desegregation strategies.

**HEALTHCARE:** On coronavirus pandemic, "I said, among others, that, you know, you should get into China, get our experts there, we have the best in the world, get them in so we know what's actually happening', Biden said. [Claims] 'there was no effort to do that'. The U.S. Centers for Disease Control and Prevention tried to get into China just one week after China reported the outbreak to the World Health Organization on Dec. 31, 2019."9 "... Biden said he 'will be prepared to do whatever it takes to save lives'," 10 even shutting down the country again.

Biden's aggressive advocacy for LGBT issues extends into his approach to foreign policy. He has promised to install a "point person" for LGBTQ+ issues on the National Security Council and a special envoy at the State Department to combat "homophobia, transphobia, and stigma globally."<sup>11</sup>

**IMMIGRATION:** "'We're going to restore our moral standing in the world and our historic role as a safe haven for refugees and asylum-seekers'." 12

**LAW AND ORDER:** Biden ... aims to pass legislation abolishing the death penalty at the federal level and offer incentives to states to follow suit. Convicted criminals who would face execution under current law would instead be sentenced to life in prison without parole.

His plan also would decriminalize marijuana and expunge past cannabis-related convictions, end the disparity between sentences for powder and crack cocaine, and do away with all incarceration for drug use ... . In addition, it would create a \$20 billion grant program to spur states to move from incarceration to crime prevention and would eliminate mandatory-minimum sentences."<sup>13</sup>

**NATIONAL DEFENSE:** "Former Vice President Joe Biden said this week that, if elected president, he doesn't foresee major reductions in the U.S. defense budget as the military refocuses its attention to potential threats from 'near-peer' powers such as China and Russia. But internal pressure from the progressive wing of the Democratic Party, combined with pandemic-related economic pressures, may ultimately add up to budget cuts at a Biden Pentagon. ... Biden avoided any sweeping pronouncements about how defense spending might change in his administration. '... we need priorities in the budget,' Biden said, adding that the Pentagon must invest in emerging technologies. 'We have to focus more on unmanned capacity, cyber and IT, in a very modern world that is changing rapidly', Biden said."

**ABORTION:** Keep the government out of it, no subsidies, no regulations.

**EDUCATION:** Will work to eliminate the Department of Education and return control of education to where it belongs – with parents, teachers, and students."

**ECONOMY:** We need to make government smaller. The real cure for poverty is a vibrant economy that generates plentiful jobs and high wages, combined with an affordable cost of living.

**HEALTHCARE:** Can reduce the cost of health care 75% by allowing real price competition, and by substantially reducing government and insurance company paperwork. This will make health care affordable for most Americans, while also reducing the cost of legacy programs like Medicare, Medicaid, and the VA. The COVID-19 pandemic has revealed a tale of two Americas: the one driven by career politicians in Washington, and the one created by the American people. She supports the legalization of marijuana.

**IMMIGRATION:** Our policies on immigration should be just as free and open. ### MICHAEL R. PENCE (Republican, Incumbent)

Born in Columbus, IN. Christian. BA in American History, Hanover College (1981); JD, School of Law, Indiana University (1986). Candidate for U.S. House of Representative in 1988 and 1990. Member U.S. House of Representative (2000-2012); Governor, Indiana (2012-2017); President, U.S. Senate (2017-present); Vice President, U.S.A. (2017-present). Formerly, Chair, House Republican Study Committee; Member, Tea Party Caucus; Chair, House Republican Conference; Member, Congressional Task Force Against Anti-Semitism; Member, Congressional Internet Caucus.

Has also played a pivotal role as a tie-breaking vote in the Senate, which is a duty given to vice presidents, who are also presidents of the Senate. Cast the first tie-breaking vote to confirm both a Cabinet member and a judicial nominee in congressional history."1

ABORTION: "... staunchly conservative on social issues including opposition to abortion rights and same-sex marriage. ... As governor of Indiana, Pence signed into law restrictive abortion measures that banned women from seeking an abortion based on an unborn child's race, gender or disability. The measure also required fetal remains from abortions or miscarriages to be buried or cremated. Two years after it went into effect, the 7th U.S. Circuit Court of Appeals ruled that it was unconstitutional. But in 2019, the Supreme Court upheld the part of the law that required burial of fetal remains. ... As vice president, Pence cast the tie-breaking vote in the Senate to defund Planned Parenthood in 2017."1

ECONOMY: Vice President "pressed on with a positive message about declining unemployment, the headline-making August jobs report and downtrends in coronavirus infection rates across states that faced major outbreaks earlier this summer. 'On this Labor Day [Pence told workers], it's important to remember that in the last three years wages were rising at their fastest pace in the last decade'." He continued: '... keep pressing on. Keep showing the strength and the faith and the resilience that working people have always shown in the history of this nation. Keep standing with us and we'll keep standing with you'."

EDUCATION: Supports publicly funded vouchers to pay private school tuition for low and middle-income families and for charter schools; adopted, but then rejected, Common Core state standards in Indiana; established scholarship program for teaching; fights for innovation and reform by funneling resources, not red tape, from the federal government to local schools. 18

**HEALTHCARE:** Head of the White House coronavirus task force. "... federal government ... arranged for the distribution of hundreds of millions of medical supplies – PPE ... . We worked to develop therapeutics - medicines that help people that are struggling. And even through today, Johnson & Johnson just announced another major step toward obtaining a vaccine. ... We really do believe that, through Operation Warp Speed, that we could well have a coronavirus vaccine for the American people – millions of doses of the vaccine – before the end of this year. ... We need to open up America's churches and houses of worship because faith is the wellspring from which the American people have always drawn strength in challenging times.

On ObamaCare: "Republicans have been offering solutions from the beginning. Let people purchase health insurance across state lines, pass malpractice reform, cover preexisting conditions. All of that can be done without a massive, trillion-dollar expansion of the federal government and burdening future generations with more deficits and more debt."2

IMMIGRATION: "Every day we don't secure our border, we're allowing the crisis to worsen, more lives to be endangered, and more people to be exploited, and more drugs to flow into our country. That's why President Trump used his authority under the law to declare a national emergency on our southern border. We call on every member of Congress: Stand up for border security, stop playing politics with the security of the American people, and stand with President Trump for a stronger and safer America.<sup>21</sup>

LAW AND ORDER: "The president and I will always support the right of Americans to peaceful protest," Pence said. "But rioting and looting is not peaceful protests. Burning businesses is not free speech. Bringing violence against innocent civilians or those in law enforcement must stop and it must stop now.'

NATIONAL DEFENSE: A strong supporter of Israel."... we must be prepared to confront and expose the vile tide of anti-Semitism that is fueling hate and violence all across the world and we must stand together," Pence told an audience of world leaders during a Holocaust memorial forum in Jerusalem.<sup>23</sup>

### KAMALA D. HARRIS (Democrat)

Born in Oakland, CA, and lives in San Francisco, CA. Her mother is from India and her father is from British Jamaica. BA in Political Science/ Economics, Howard University (1986); JD, University of California, Hastings College of the Law (1990). Attorney General, State of California (2011-2016); Senator, United States Senate, California (2017-present). Current Legislative Committees include: Member, Subcommittee on The Constitution; Subcommittee on Intellectual Property; Subcommittee on Federal Spending Oversight and Emergency Management; Select Committee on Intelligence; Permanent Subcommittee on Investigations;

Judiciary; Homeland Security and Governmental Affairs; and Budget.

Harris ran for the 2020 Democratic presidential nomination and attracted national attention before ending her campaign on December 3, 2019. On August 11, 2020, she was announced as former Vice President Joe Biden's running mate in the 2020 election.

Speaking during a virtual roundtable with small business owners in Arizona, Harris vowed that they will have an ally in the White House with the campaign's "Build Back Better' initiative. .. 'A Harris administration, together with Joe Biden as the president of the United States', she said. She quickly clarified, 'The Biden-Harris administration will provide access to \$100 billion in low-interest loans and investments from minority business owners'."24

ABORTION: "It is incumbent upon Congress to pass the Women's Health Protection Act, which would prohibit states from enacting laws that impose burdensome requirements on access to abortion.<sup>25</sup>

"In her brief run for president [nomination 2020], she campaigned on a series of extreme anti-life positions, including codifying Roe v. Wade into law, requiring preclearance for state abortion laws, repealing the Hyde Amendment, repealing the Mexico City Policy, preserving federal funding for Planned Parenthood and banning abstinence-only sex education. As attorney general, she confiscated hard drive videos, which exposed Planned Parenthood's illegal sale of aborted fetal tissue.26

ECONOMY/TAXES: "Harris ... tweeted, 'the average tax refund is down about \$170 compared to last year. Let's call the President's tax cut what it is: a middle-class tax hike to line the pockets of already wealthy corporations and the 1%'."

**EDUCATION:** Harris sponsored a 2010 law to make it a misdemeanor for parents whose young children miss more than 10% of school days a year without a valid excuse. In an interview on CNN's "State of the Union," Harris said her initiative improved school attendance in San Francisco and 'not one parent was sent to jail. ... When we define truancy, we defined it as three or four unexcused absences. I was seeing kids that were missing up to 80 days of a 180-day school year. So, my point was, why isn't the education code recognizing that? ... by changing the education code, it also changed ... the penal code. And then that was an unintended consequence. And if I could do it over again, I would have made sure that it would not have increased penalties or the ability to prosecute anywhere in the state to prosecute parents, because that was never the intention. And it was never anything that I did'."

IMMIGRATION: Through deferred action immigration programs and executive actions believes in removing "the threat of deportation of millions of undocumented people in the United States." During her initial bid for president, she said, '... while I fight for Congress to pass 21st Century immigration reform, I won't wait. I'll take action to lift barriers Dreamers face to pursuing legal status and put them on a meaningful path to citizenship. These young people are just as American as I am, and they deserve a president who will fight for them from day one.' This is not the first time Harris has proposed going around Congress and using executive action to tackle a core Democratic issue. Harris announced in April that she would use the power of the presidency to enact sweeping gun control measures if Congress fails to send comprehensive legislation to her desk in her first 100 days."28

LAW AND ORDER: Has a record as a tough prosecutor – but also stirred controversy during that period for allegedly going easy on criminal defendants in a number of cases, including by refusing to seek the death penalty for a cop killer. She often did not seek punishments to the full extent of the law as the San Francisco district attorney and California attorney general.<sup>29</sup>

NATIONAL DEFENSE: Calls for slashing the defense budget. She "pledge[s] to double the size of the civil rights division of the Justice Department: 'Justice means recognizing domestic terrorism, including white nationalist extremism,' which Harris said 'should be considered a national security priority'."

**HOW DO WE SELECT A CANDIDATE?** 

We the People of the United States, in Order to form a more perfect Union ... We are all familiar with the first sentence of the Constitution of the United States, Perhaps fewer are familiar with the first section of the first article immediately following that preamble. Order and priority were not overlooked by the men who drafted our governing documents and who vested the power of that new government where it belonged, in the hands of the people of the nation. WE the PEOPLE had thrown off the tyranny of man's rule through monarchy and reclaimed our sovereignty under the laws of Nature and of Nature's God. Therefore, it is right and reasonable that Article I, Section 1 of the Constitution states, All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives. Section 2 goes on to describe the People's House which "shall be composed of Members chosen every second Year by the People of the several States ..." It is only after the Legislative Branch is defined that the Executive and the Judicial branches are outlined, in that order. This is not an afterthought, but a logical progression of what stems from of the People, by the People, and for the People.

Samuel Adams, a signer of the Declaration of Independence, held a high standard for those who would serve in the government. "Nothing is more essential to the establishment of manners in a State than that all persons employed in places of power and trust be men of unexceptionable characters. The public cannot be too curious concerning the characters of public men." Character is some indication of future behavior, "Neither the wisest constitution, nor the wisest laws will secure the liberty and happiness of a people whose manners are universally corrupt." The admonition of

our founders to choose wise, moral, and religious persons is still sound advice. A good indicator of what our representatives will do in office is to look at what they have done in the past and who endorses that behavior. That is why we have provided information on endorsements and committees for each candidate (when available).<sup>3</sup>

We have also included a brief description of the groups that rate or endorse candidates. Again, the adage "deeds, not words" is important in evaluating each group's philosophy. Their support for legislation is their "deeds." Most of these groups have promoted legislation that causes them to be positioned either in the progressive/socialist/liberal camp or the conservative/pro-family/free-market camp. *FRONT LINE* encourages our readers to explore further the candidates that appeal to them and then get involved in their election. Where available, the candidates' websites are included for further research.

We have used (unless otherwise indicated) Votesmart.org and Ballotpedia.org, which provide non-partisan, impartial, and in-depth information on candidates for public office. For further explanation of interest groups, see https://justfacts.votesmart. org interest groups. For those that wish to see some of the votes cast by those candidates that are presently serving in Congress, go to https://ballotpedia.org, and check on the Key Votes of the 116th Congress 2019-2020 by member's name. This is just a snapshot of some of the more known issues and by no means is a complete picture of the member.

(Republican, Incumbent) Born in

Missouri, and lives in Bolivar, MO.

Attended both the University of

Hawaii and University of Maryland after graduating high school in 1973.

Married with two children. Served in the United States Army and as the Sheriff of Polk County. Has been a business owner and is a third generation farmer. Member of First Baptist Church, Bolivar, Mo. Member of the Cattlemen's Association, Missouri Farm Bureau, Missouri Sheriff's Association, National Rifle Association, National Sheriff's Association, and the Optimist Club.

Opposes embryonic stem cell research. As a Missouri congressman, in 2011, he signed the "no new tax pledge" for Missouri; supports requiring ride-sharing companies to have comprehensive insurance plans; pro-life; pro Second Amendment; opposes Obamacare. During his first year in office, the state economy increased by over 35,000 new jobs. Bunge, Bayer, Briggs & Stratton, CVS, Nucor Steel, Google and others are investing in Missouri and creating new opportunities for Missourians. The legislature passed, and Governor Parson signed, the largest income tax cut in Missouri history.

Elected Missouri's Lieutenant Governor (2016); member

of Missouri State Senate (2011-2017), MO House of Representatives (2005-2011) and sheriff of Polk County (1993-2004). In a *Tweet* on September 10, 2019, Parson was endorsed by President Donald Trump.

"Judge David **Jones** sentenced [Joshua] Hagood to 100 years for armed criminal action, 15 years for unlawful possession of a firearm by a felon, and a life sentence in prison for assault in the shooting of a Springfield, Missouri police officer. Officer Aaron Pearson was shot in the face by Hagood in January of 2015, causing severe injuries. Pearson['s] injuries ended his law enforcement career."<sup>32</sup>

Judge **Jones** said a man [was] fearing for his life and an uncle who had a history of violence were involved in a fatal shooting. "This is probably the most difficult sentencing I've ever had, **Jones** said. ... **Jones** asked the attorneys, "Why is Watts charged with involuntary manslaughter – not murder?" The prosecuting attorney defended the decision to cut a plea deal. **Jones** sentence Watts with seven years in prison for involuntary manslaughter, suspended the execution of the sentence, and put him on probation, ordering him to perform 300 hours of community service. **Jones** told Watts, 'All I can say is this: You don't ever want to see me again'."<sup>33</sup>

### It Isn't Going Away

As new coronavirus cases continue to climb in America, health experts say it's becoming clear that the virus, known as SARS-CoV-2, is here to stay—but experts say that, between emerging treatments and a possible vaccine, we won't be stuck in a perpetual global pandemic, either.

No matter what we do to curb the novel coronavirus—whether through social distancing, wearing masks, or developing a vaccine—one thing is "almost certain: This virus is never going away." ... public health officials were optimistic when the virus first hit that countries could eradicate the pathogen, given its similarity to the coronavirus that causes SARS-which emerged in 2002 and was "snuffed out" among humans, ... by 2004. But unlike the coronavirus that causes SARS, the new coronavirus, SARS-CoV-2, spreads more easily and can spread asymptomatically—meaning that a lot of the strategies used to curb SARS are ineffective against the novel coronavirus. ...

Health experts say it's likely that enough people will become infected with or vaccinated against the novel coronavirus to end the global pandemic, but that the virus will probably continue to infect people at lower rates. ...

A vaccine that provides short-term immunity could require booster shots over time, like the flu shot. ... But the most likely, best-case scenario, a vaccine would make the new coronavirus "a much less dangerous and less disruptive" threat, such as the flu or other seasonal respiratory viruses ... In this scenario, SARS-CoV-2 would become the fifth coronavirus—joining four other coronaviruses that cause a considerable proportion of common colds—that circulates among humans regularly and seasonally. ... "I think this virus is with us to the future," said Ruth Karron, a vaccine researcher at Johns Hopkins. "But so is influenza with us, and for the most part, flu doesn't shut down our societies. We manage it."

In fact, research suggests—although it doesn't prove—that at least one of the four coronaviruses linked to common colds, OC43, may have started as a pandemic before "settling in as a routine virus. .. And while that research is entirely speculative, it could potentially be good news, in that it suggests SARS-CoV-2 may become less deadly as it transitions from a pandemic to a "common cold" especially given that the other four coronaviruses may be less harmful because human bodies have built up an immune response to the pathogens over time.

"All of this, along with immunity from vaccines, means that [the novel coronavirus] is likely to become far less disruptive down the line. ... "In this way, the long-term outlook for [the coronavirus] might offer some hope for a return to normal."
